Between August 2023 and the conclusion of December 2023, our office assisted a total of 9 clients, all of whom expressed a desire to initiate business ventures in the near future. Among these clients, 5 expressed an interest in establishing a Sole Proprietorship Business, while 3 were eager on founding a Limited Company (VBA). One client remains undecided about the legal structure for his business.

In terms of demographics, 6 of the clients were female, 3 were male, and 3 were born in Aruba, with the remaining 6 clients hailing from various countries, including Venezuela, Colombia and Peru.








Workshop 3


